Principals,

I am emailing today regarding the new district literacy curriculum, Clever Minds. During conversations and school visits, I am being made aware of a level of resistance to this new curriculum. It has been seven years since we adopted new literacy curriculum in the district, and we are most certainly overdue for a change as our literacy scores have been stagnant in recent years. Change is hard - I realize that – but this change to Clever Minds is a **non-negotiable**. We will proceed with full implementation of this curriculum and expect to see it used with fidelity across all classrooms. As a reminder from our recent principals' meeting:

- 1. The Board approved adoption of this curriculum and district policy states that approved curriculum is the only curriculum to be used in schools.
- 2. Our literacy scores dictate that inaction is unacceptable. This shift in curriculum is the action we are taking to make a difference across the district.
- 3. Teachers who do not implement the curriculum will face disciplinary action including, up to, termination.

This is the path forward in our district. I expect you all to be positive spokespeople for this change to help with implementation.
